**Traffic Safety Request Under the Age of Eighteen**

1. Complete the Request for Supervision in duplicate. Have your signatures notarized or wait to sign until you are filing the petition at our counter with your parent or legal guardian.
2. Bring the Request for Supervision forms to the Circuit Clerk's office to get a court date.
3. Complete the Notice of Hearing found in box 6 (two copies).
4. Deliver one copy of each form to the Circuit Clerk's office and deliver one copy to the State's Attorney's office at least 14 days prior to the court date on your Notice of Hearing.
5. Appear with your parent or legal guardian on the assigned date.
6. If the Judge allows you to take Supervision you will need to pay the additional \$49 and complete the application as you leave the courtroom on your assigned court date.

**Forms must be turned in prior to the may appear date at the bottom of your ticket.**
