**UNPAID FEES AND RETURN CHECK FEE**

**Unless a Court Ordered payment schedule is implemented, or the fee requirements are waived by Court order, the Clerk is authorized to add to any unpaid fees and costs a delinquency amount equal to 15% of the unpaid fees that remain unpaid after 90 days. Delinquency amounts collected pursuant to this provision shall be deposited into the Circuit Clerk Operation and Administrative Fund to defray additional administrative costs incurred by the Clerk in collecting unpaid fees and costs.**
